Why is bed bug prevention so much more powerful than reactive treatments?

2 What is the ATAHC Program? How does it work?

ATAHC is a bed bug control and prevention program that virtually eliminates bed bugs in affordable housing, protecting our country's most at-risk residents. The Program is proven to reduce reintroductions by more than 99 percent. While core principles of ATAHC include early detection and intervention, a critical component leading to Program success is our formation of a collaborative partnership with property management, staff and residents. The "magic" occurs when these stakeholders work together toward a solution.

Why is collaboration between residents, pest management, building staff and management such a key component for preventing and controlling bed bugs in affordable housing? Affordable housing represents a significant challenge for property managers and PMPs tasked with controlling and preventing bed bugs in these complex environments. Many hurdles have historically stood in the way, with pest management professionals often citing the lack of resident cooperation. Through ATAHC, our coordinated partnership with PMPs, residents and property managers has resulted in a comprehensive prevention program that has produced impressive, longterm results while saving time and money.

Are you having success with ATAHC in the affordable housing market? The ATAHC pilot proved that our approach to controlling and preventing bed bugs in affordable housing can — and does — work. For over two years, more than 99 percent of residents in a 470 unit complex did not experience a reintroduction of bed bugs; the property management company saved more than \$40,000 per year; and there was a 40 percent reduction in technician time on site, saving PMPs labor expense through better staff deployment. These data spearheaded the contract award of \$15 million to Allergy Technologies for the implementation of ATAHC throughout 6,000 units under the Philadelphia Housing Authority.


5 How can PMPs make ATAHC part of their business?
